Note from the President



Pets are wonderful companions, particularly during challenging times. In over 30 years in Country Club Hills, we've owned a German Shepherd, Golden Retriever, three Scottish Terriers, and now two King Charles Cavalier Spaniels. They truly become a part of the family. It is great to take your dog for a walk; it's good for your dog and for you.

With this blessing come responsibilities. Allen County regulations require your dog to be licensed. Annual dog registration is \$22.00 per tag by January 31 of each year. The license may be renewed or purchased online via the Allen County Auditor's website, or in person, Monday through Friday at: The Allen County Courthouse, Auditor's Office Room 106, 301 North Main Street, Lima, 8:00 a.m. to 4:30 p.m.

These responsibilities also include controlling your dog and cleaning up after them. Be a good neighbor and be a Pooper Scooper! It's only fair that you take care of the deposit and properly dispose of it.

It's important to control your dog so it doesn't harm your neighbor, or their pets, and is not allowed to run at large. According to Ohio Revised Code, Section 955.22(C):

"No owner of any dog shall fail at any time to keep it either physically confined or restrained upon the premises of the owner by a leash, tether, adequate fence, supervision, or secure except when the dog is lawfully engaged in hunting accompanied by the owner."

It's often best if neighbors can mutually resolve any dog issues. However, the Dog Warden will respond to situations when needed: a dog is running at large, a dog has bitten another dog, or a person has been bitten. Incidents can be referred to the Allen County Dog Control Department at 419-223-8528 during office hours on Monday through Friday, from 9:00 a.m. to 5:00 p.m.

If the Dog Warden can't be reached, you can also report dangerous dogs running at large, or a dog who has bitten, by calling the Allen County Sheriff's Office at: 419-227-3535.

The Dog Warden has no authority over barking dogs. The only recourse is tocall the Sheriff's Office and make a noise ordinance complaint. For more information see the Allen County website: <u>https://www.allencountyohio.com/dog-control</u>.


